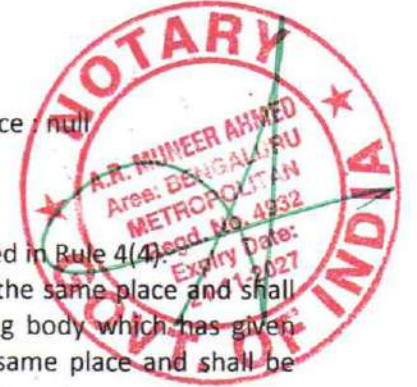

Conditions:

1. This registration is subject to rule 3(5) (4).
2. The Governing Council shall comply with all the conditions mentioned in Rule 4(4).
3. The school shall be opened only in the sanctioned medium and at the same place and shall not be allowed to change the place for any reason. The governing body which has given permission to run the school is the same governing body at the same place and shall be conducted under the same name.
4. This educational institution shall comply with all Government orders and regulations in force and issued from time to time in relation to educational institutions. The Karnataka Education Bill 1983 (Karnataka Ag No:1:96) made the Acts thereunder and the rules framed in Arapadi must be followed without fail.
5. Subject to the condition of providing school premises, area, building furniture, staff, financial facilities etc., the said educational institution shall not under any circumstances open more departments without the prior permission of the Government.

Director General, Karnataka State Fire and Emergency Services, Bangalore vide Circular No. GBC (1) 502/2004 dated 08/07/2020 regarding fire safety Director General, Karnataka State Fire and Emergency Services, Bangalore vide Circular No. GBC (1) 502/2004 Dated: 08/07/2020 Certificate obtained from Competent Authority Update from time to time. Submission to concerned Deputy Director.
18. Certificate regarding building safety to be renewed from time to time by the competent authority and submitted to the concerned Deputy Director.
19. If the documents uploaded online are not genuine, this order will be canceled forthwith.
20. Service security rules must be followed in the school.
21. At the time of first approval, the first approval shall be given only after verifying the genuineness of the original documents uploaded in the software such as conversion land record, building safety certificate and fire safety certificate.
22. Submission of proposal to this office within 03 months for first recognition. Deputy Director Education Act and Government Order Dated: 30/09/2007 check list vide Annexure 03 and on this basis first accreditation must be obtained within three months of the commencement of the school, in case of non-accreditation within the prescribed period, the registration will be canceled immediately.
23. After completion of the school registration process, the entire document/information in the application submitted online by the management will be made available for public viewing on the departmental website.

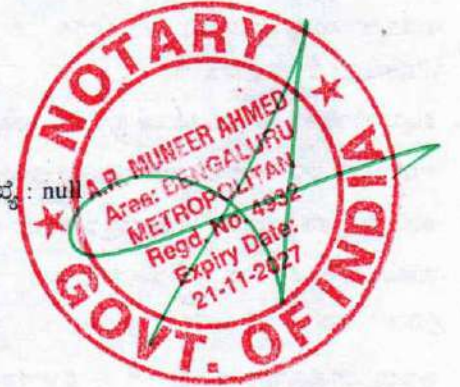
